 - San Jose Central Elementary School; and





NTD Dance Craze Competition

MECHANICS AND CRITERIA:

1. The competition is open to all Senior High School Division of Negros Oriental.
2. Each District must send a contingent that shall compose of at least 8-10 bona fide students. A parent's consent shall be obtained by the school head.
3. The participating district shall submit a list of participants using the template (please see attached) to Felix III D. Mosqueda, Nurse-In-Charge at felixiii.mosqueda@deped.gov.ph, and enclose the parent's consent.
4. The official music to be used in the competition is the PDA National Toothbrushing Day Jingle titled, "Brush s aumaga, Brush sa Gabi" which can be accessed through this link, bit.ly/3RmDGjC.
5. Each contingent may develop their own choreography.
6. An **Elimination Round** will be conducted on **February 3, 2023 from 9:00 AM to 12:00 noon via Zoom, Meeting ID: 833 4384 6089; Passcode: 774065.** ONLY the TOP 5 highest scorers shall proceed in the **Final Round** which will be conducted on **February 6, 2023 in Amlan Central Elementary School** from 8:30 AM to 3:00 in the afternoon.
7. The contingent may opt to wear their costume, however, the costume must be decent and appropriate to the chosen theme.
8. Use props is allowed but should secure the safety of the participants and audience.
9. Below is the criteria which will be used to select the finalists and winners of the contest:

Criteria for Judging:

Message and Mastery of the Dance	- 50%
Choreography	- 30%
Audience Impact	- 10%
Overall Impact	- 10%
Total	- 100%

10. The Winning Contingents shall receive the following rewards:

1 st Prize Winner:	PhP 5,000 cash and trophy
2 nd Prize Winner:	PhP 4,000 cash and trophy
3 rd Prize Winner:	PhP 3,000 cash and trophy
4 th Prize Winner:	PhP 2,000 cash and trophy
5 th Prize Winner:	PhP 1,000 cash and trophy

11. The decision of the judges is final and irrevocable.

QUIZ BOWL General Guidelines:

1. The Quiz Bowl is open to **ALL Senior High School learners of the Division of Negros Oriental**. Each **District Office** shall send only **ONE representative**.
2. The quiz bowl is composed of three rounds: **Easy, Moderate, and Difficult**. In the event of a tie, there will be a Tie-Breaker round. Each round will have ten (10) questions each. **Easy** round questions are worth 3 points each, **Moderate** round questions are worth 5 points each, and **Difficult** round questions are worth 10 points.
3. All questions in the easy and moderate rounds are of a multiple-choice type. No choices shall be provided for the answers to questions for the difficult round.
4. At the end of each round, the cumulative score of each team will be computed.
5. The team that scores the highest wins the quiz bowl.

Reading Mechanics:

1. Questions will be read twice by the quiz master.
2. Teams will be given 10 seconds to write their answer during the easy round, 15 seconds during the moderate round, and 30 seconds during the difficult round.
3. The bell will ring once the time for answering is up and teams will have to stop writing and raise their answers.

Answering Mechanics

1. Each team will be provided a board to write their answers on.
2. Answers must be written legibly in big letters.
3. Audience must observe silence at all times. Coaching is strictly prohibited and will result in automatic disqualification of the team receiving the coaching.

Protest Mechanics

1. A protest may be raised by any contestant. All protests shall be forwarded to the judges for decision.
2. Protests regarding a particular question will be entertained only before the next question is read. Once the next question is read, no protest regarding the previous question will be entertained.
3. During the protest, the contestant has the privilege of consulting any reference, provided they are relevant to the subject of the protest.
4. The Board of Judges shall be given a maximum of two (2) minutes to resolve the protest after which the contest shall go on. Should the judges fail to resolve the protest within the allotted time, the said question shall be held in abeyance until the same has been resolved.
5. The Board of Judges will act on any concern regarding the questions and answers **ONLY**.
6. The decision of the Board of Judges shall be final and executory.

Tie Breaking Mechanics

1. In case of a tie at the end of the last phase of this contest, a tie breaker will immediately ensue and will be sudden death in nature.
2. Questions of any difficulty and type will be asked until one contestant gains an advantage in score of 2 points over the other.
3. The first contestant to gain that advantage in score will be declared the victor of the tie and will merit the corresponding award.
