MONITORING AND EVALUATION OF SCHOOLS' CONDUCT OF LEARNING ACTION CELL



- In the quest of ensuring that the schools of the Division of Negros 1. Oriental is attuned to the standards of compliance as directed by the Department of Education and more specifically by DepEd Order No. 35, s. 2016 or also known as "The Learning Action Cell (LAC) as a K to 12 Basic Education Program School-Based Continuing Professional Development Strategy for the Improvement of Teaching and Learning" as well as the existence of the Department Order No. 29, s of 2022 or also known as "The Adoption of the Basic Education Monitoring and Evaluation Framework." It introduces the monitoring tool for the Learning Action Sessions for the schools.
