CONDUCT OF THE ENGLISH, SCIENCE, AND MATHEMATICS ASSESSMENT FOR THE NATIONAL LEARNING CAMP (NLC) ASSESSMENT SY 2022 - 2023

TO: Assistant Schools Division Superintendent Chief Education Supervisors, CID and SGOD DEPS, PSDS/DIC/Dist. Caretaker Public Secondary School Heads Public Secondary Teachers All Others Concerned

- 1. Pursuant to DM-OUCT-2023-14, otherwise known as the Conduct of the English, Science, and Mathematics Assessment for the National Learning Camp Assessment released by the Office of the Undersecretary for Curriculum and Teaching last June 9, 2023, this Office through the Curriculum Implementation Division and ICT Unit hereby informs all public secondary schools to conduct the NLC assessment.
- 2. The National Learning Camp (NLC) Assessment Pre-Test shall be administered to all Grades 7 and 8 learners in all public secondary school on June 21 to July 7, 2023, SY 2022-2023 and the Post-Test shall then be conducted on August 2023 to Grades 8 and 9 learners for SY 2023-2024 (Same cohort).
- 3. The NLC Assessment is an online computer-based test that will be delivered through the DepEd LMS Moodle platform which will be administered to testing centers compliant with technical specifications set by the DepEd Central Office. This assessment is a learning recovery approach aligned with the MATATAG Agenda to give transformative, concrete, and targeted reforms to further enhance the country's education system.
- 4. The said assessment shall cover the learning areas in English, Science, and Mathematics, wherein test items measure varying level of skills and competencies in a multiple-choice format using English language.
- Public Schools District Supervisors/ District in-charge/ District Caretakers are advised to monitor the conduct of the National Learning Camp Assessment in their respective district.
