





**QUARTER 2 CURRICULUM IMPLEMENTATION REVIEW IN MULTIGRADE (MG),  
KINDERGARTEN, AND SPECIAL EDUCATION (SPED)**

To: Schools Division Superintendents

1. This Office, through the Curriculum and Learning Management Division, will conduct Quarter 2 Curriculum Implementation Review in MG, Kindergarten, and SPED on April 17-21, 2023, from 8:30am to 5:00pm via MS Teams.

2. The activities aim to provide updates in MG, Kindergarten and Special Education, review and provide feedback on the extent to which the different PAPs in multigrade, kindergarten and SPED as reflected in the 2023 implementation plan are achieving the goals, identify actual or potential successes and indications of the progress, problems, or lack thereof to facilitate timely adjustments and modification to PAPs operation as and when necessary, and to determine whether the resources available are sufficient and are being well used.

3. Participants to the activity from each division shall be composed of the following:
