





To: Schools Division Superintendents

1. In support of the department's MATATAG Agenda, this Office, through the Curriculum and Learning Management Division, will conduct a writeshop on the Development of Learning Activity Sheets for Key Stage 1 Learners in the Multigrade Set-up Phase 2, on December 11-13, 2023 at Molave 1-DepEd Ecotech Center, Cebu City.
2. The activity aims to develop inclusive learning activity sheets (iLAS) of least learned competencies in English, Science and Math for grades 1, 2 and 3 learners in the multigrade setting including the special education classes.
