

**CONDUCT OF THE NATIONAL, REGIONAL AND DIVISION SCREENING AND
ACCREDITATION COMMITTEE MEMBERS**

To: **Schools Division Superintendents
All Others Concerned**

1. The Department of Education (DepEd), in coordination with the Philippine Sports Commission (PSC) and the Department of Interior and Local Government (DILG), shall conduct the 63rd Edition of the Palarong Pambansa from July 29-August 5, 2023 in Marikina City.
2. In view of the foregoing and to ensure that all learner-athletes, coaches, assistant coaches and chaperones are qualified to participate in this year's edition of the annual scholastic multi-sports competition, there will be a **Conference of National, Regional and Division Screening and Accreditation Committee Members** on April 1-4, 2023 at the Bayleaf Hotel, General Trias, Cavite.
3. This conference aims to:
 - a. Capacitate the members of the Regional/Division Screening and Accreditation Committee (RSAC/DSAC) on the revised rules on screening and accreditation of learner-athletes, coaches, assistant coaches, and chaperones; and
 - b. Develop a system for the digitization of documents, preparation of PasSport for learner-athletes/coaches/assistant coaches, and finalization of the master list.
4. Participants are expected to be at the venue on April 1, 2023. First meal to be served is AM Snacks of April 1, 2023. Last meal to be served is PM Snacks of April 4, 2023.
5. Schools Division Superintendents are advised to issue Travel Authority to their respective DSAC representative.
