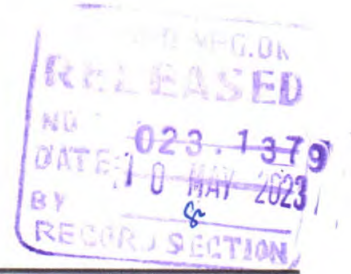



SUBJECT : 66th ANNUAL NATIONAL COUNCIL MEETING (ANCM)

1. Pursuant to the provisions of R.A. 7278 and the By-laws governing the Boy Scouts of the Philippines, the National Executive Board (NEB) has approved the conduct of the **66th ANNUAL NATIONAL COUNCIL MEETING (ANCM)** on **10-12 May 2023** at Leyte Academic Center, Palo, Leyte.
2. The conference details are as follows:

PURPOSE

As provided in Section 1, Article V of the BSP National By-laws, the National Council shall be convened annually to:

- Receive reports of the National President and the National Treasurer
- Elect four (4) regular members of the National Executive Board
- Ratify any proposed amendments to the BSP Bylaws (if any)
- Conduct the National Court of Honor and other awarding ceremonies
- Discuss other business as may properly come before the meeting

PARTICIPATION

The official delegates of the conference are the following:

- a. National Executive Board Members
- b. Regional Chairmen and Regional Scout Commissioners
- c. Council Chairmen and Council Scout Commissioners
- d. Officially designated Local Council Executive Board (LCEB) Members
- e. Council Scout Executives/Officers-In-Charge (observer)

Other regional and local council officers who wish to attend the conference may do so, as **observers**. Observers may participate in deliberations but they shall have **no right to vote**.

AWARDING CEREMONIES

The awarding ceremonies include (but are not limited to):

- a. Tribute to the Scoutmasters
- b. Outstanding Regional/Council Commissioners
- c. Outstanding Regional/Council Chairpersons

ELECTION OF REGULAR MEMBERS


- a. Each Local Council shall be entitled to **four (4) votes** only, but will be entitled to one (1) additional vote for every ten thousand (10,000) of its Scout Membership as of **December 2022**. The additional vote(s) shall be cast only by the Head of Delegation.
- b. Participating Council Scout Executives shall be allowed to vote in behalf of the council's voting delegate provided that **he/she is the only official delegate from his/her local council**, and that a **Council Executive Board resolution has been submitted to the BSP National Office not later than 31 March 2023**.

REGISTRATION/CONFERENCE FEE

- a. Attendance and participation for the Local Council's and Regional Scouting Committee Key-Three Officials (Council/Regional Chairmen, Council/Regional Commissioners and Council Scout Executives) are **FREE OF CHARGE**.
- b. For other members of the Local Council Executive Board, each shall pay a conference fee amounting to **Six Thousand Pesos (Php6,000.00)** to cover cost of souvenir items, supplies and meals from 10 May 2023 (afternoon snack) up to 12 May 2023 (lunch). The conference fee **DOES NOT** cover **breakfasts** since they are usually included in the hotel's accommodation.
- c. Payment should be made through the Land Bank of the Philippines account with the following details:

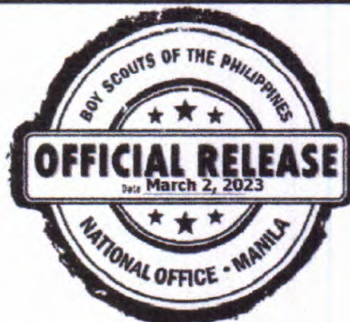

1. NUMBER OF VOTES PER COUNCIL FOR THE ELECTION OF NEB REGULAR MEMBER

Article IV, Section 3 of the BSP National By-Laws provides that each duly chartered Local Council shall be represented in the National Council by the Local Council Chairman and the Council Scout Commissioner and such other delegates it may designate. Each Local Council represented in the annual or special meeting of the National Council shall be entitled to four (4) regular votes plus one (1) vote for every ten thousand (10,000) of their Scout membership.

In this connection, herewith attached is the number of votes to be cast for each local council including the additional vote for every ten thousand of their Scout membership as of 31 December 2022 for the election of four (4) Regular Members of the National Executive Board.

The additional vote/s shall be cast by the Head of the Delegation of the Local Council.
